Mrs. Little presented Resolution Z-1250-06-23 which is regarding Case S-01-05-23, a petition submitted by Eric Rubright requesting a Special Use Permit to allow the operation of the sale and transfer of a firearms and ammunition business in (A-1) Agricultural zoning on property commonly known as 1804 E. Hampshire Road, Maroa, IL 61756 in Maroa Township. After hearing the evidence, the Zoning Board of Appeals voted to recommend approval of the subject petition with 5 stipulations. The EEHW Committee met and reviewed the petition and recommended the County Board approve the petition subject to the 5 stipulations recommended by the Zoning Board of Appeals. Additionally, the EEHW Committee recommended a stipulation be added that no advertising signs be allowed.

## MOTION CARRIED. (MAIN MOTION Z-1250-06-23 AS AMENDED)

10. Mrs. Little presented Resolution Z-1251-06-23 which is regarding Case S-04-05-23, a petition submitted by SolAmerica Energy, LLC requesting a Special Use Permit to allow the development and construction of a solar energy system on approximately 12 acres of an existing 38.33 acre tract of land in (A-1) Agricultural zoning on property commonly known as Cundiff Road, Decatur, IL (the Northeast corner of Cundiff & Brush College Road) in Whitmore Township. After hearing the evidence, the Zoning Board of Appeals voted to recommend approval of the subject petition with 6 stipulations. The EEHW Committee met and reviewed the petition and recommended the County Board approve the petition subject to 6 stipulations recommended by the Zoning Board of Appeals.

Mr. Greenfield: Mr. Greenfield said it is the wrestling building across the street and will be used by the County Clerk's office.

#### **NEW BUSINESS:**

Mr. Greenfield: Mr. Greenfield asked Tammy to give an update on where they are with the County Highway Engineer.

Mrs. Wilcox: Mrs. Wilcox said he will be taking his test next week and it could take up to two weeks for IDOT to let him know if he passed or not. They will have to wait until he knows if he passes or not before he would notify his employer. Once he passes and is notified, then the board can take action and pass a resolution to higher him, and then they can inform the board of who he is. She said it will probably go through the July meeting. They thought they might have to have a special meeting, but should probably be able to present it at the regular meeting.

Mr. Greenfield: Mr. Greenfield said if anyone wants to know more about it they should get in touch with Tammy or him, and they would be happy to tell them. They just can't make it public yet because he has not informed his employer yet. It is nothing they are trying to hide; they are just trying to protect his current employment.

## **PUBLIC COMMENT:**

Abeer Motan: Ms. Motan spoke to the board regarding some of her concerns.

#### **OFFICEHOLDER, DEPARTMENT HEAD & EMPLOYEE COMMENTS:**

Mr. Coleman: Mr. Coleman said this past Saturday was June 3<sup>rd</sup> and that marked the 130<sup>th</sup> anniversary of the lynching of Samuel Bush on the corner of Franklin and Wood. They had a ceremony and there is a lynching marker that is currently there in its place. He was very thankful to the Judge and the Decatur Public Building Commission for being a part of that process and having that together there. It was very beautiful and was appreciated. It's a continual effort they are making and they are going to do some community education here and there. Mr. Coleman said a crucial component of this is that all governmental bodies that played some form of a part in this atrocity, whether complicit or not, offer a form of apology as an overture in respect and honor of Mr. Bush's legacy, with the Macon County Board included in such, as well as the Macon County Sheriff. Mr. Coleman said Mr. Bush was moved from the county jail under the supervision of the County Sheriff. The record says that he was overpowered, nevertheless he believes it is in the best interest of the county to offer an apology. He said he was formally making that request and would undergo the process to get that placed on the proper committee so they are able to have this done and announce such at the July county board meeting.
