### PROCLAMATIONS AND RECOGNITIONS

Mr. Greenfield read the following Proclamation: Whereas, as leaders of Macon County we believe that we have a duty to acknowledge a chapter in our County's history; and Whereas, 130 years ago Samuel Bush was taken from the County Jail and subjected to an unspeakable act of violence; and Whereas, Mr. Bush was lynched before he was given the chance to defend himself against the charges for which he was arrested; and Whereas, he was denied a fair trial and legal due process he was entitled to; and Whereas, historical accounts of this incident indicate it was racially motivated; and Whereas, while the events of this day were carried out by individuals of Macon County that have long since departed this world, we must remember our history to make sure that something like this never happens again; and Whereas we recognize the anguish and sorrow that this tragedy has surely caused and acknowledge the importance of recognizing the memory of all victims. Now, therefore, be it proclaimed, that this proclamation shall serve as a testament of the County Board's commitment to justice, unity, and sincere dialogue free from self-serving agendas and political goals; and Be it further proclaimed, that we reiterate our dedication to fostering an environment where respect, empathy, and collaboration prevail. #### **OLD BUSINESS:**

Mr. Greenfield: Mr. Greenfield said he was going to take a minute under old business because they had a gentleman that wanted to make an announcement. He wanted to do it under officeholder remarks, but Mr. Greenfield wanted to give him a little time. This gentleman has been in office for 30 years, and Mr. Greenfield was hoping he was at the meeting to announce that he was going to run again. He is revered by Democrats and Republicans alike. Mr. Greenfield said he has never run across anyone in Macon County who had a bad word to say about this man. Mr. Greenfield said he could not say enough good about him except that he truly believes he will go down in history as the best Coroner that Macon County has ever had. He is kind of afraid of what his announcement is going to be, but whatever it is he has earned it

Michael Day: Mr. Day thanked the Chairman for his kind words. He said on December 1, 2023 he would begin his 30th year of service as their Macon County Coroner. This will be his last year of service in this position. He would not be seeking re-election as their Coroner and would be retiring at or near the end of his term on November 30, 2024. Mr. Day said he made this decision after much heartfelt consideration and lengthy discussion with his family. This was not an easy decision to make. He said when he took this office in December of 1994, he made a commitment to advance this office in terms of its investigative capabilities, improvement of the interaction with other agencies that the Coroner routinely deals with, and to expand the human services to those families in need. Mr. Day said he is very proud of the Macon County Coroner's office and its current abilities. He offered his appreciation to his staff, both current and past. He also offered his appreciation to the other agencies and officeholders, both current and past. Mr. Day thanked his dear wife Kim, and his family for their years of support during these years of service. He said most of all he would like to offer his sincere, heartfelt appreciation to the citizens of Macon County who have entrusted him all of these years with this sensitive and difficult position. Mr. Day said as a side line he had a conversation with his wife Kim, and told her he really didn't know what he was going to do with the time he was going to have since he would not be doing the 12, 18 and 24 hour shifts daily. One of the most chilling responses that he could ever imagine came from her lips. She said, "Don't worry about that, I'll take care of it." Mr. Day said in all in all sincerity and seriousness he wanted to thank the board, both past and present, for all their kindnesses and assistance over the years. He said this office is a hard one. Many times they are a reactive office, whatever happens that is what they have to do. The board has been very understanding over the years in helping them make it through when they had shortfalls and some issues. He thanked them sincerely. Mr. Day said he would continue to serve the rest of his term with the same work ethic and protocol as always. He said again, many thanks to them, for all of these years. It has been a good, long ride and he hopes they made a difference for the people of Macon County.

There was no new business presented at the meeting.

### **PUBLIC COMMENT:**

Todd Rogers: Mr. Rogers said he really didn't need to speak today and the reason was because of the proclamation that Chairman Greenfield and the rest of the board passed. He said he was certainly there to support it. It made him feel good that he didn't have to because somebody figured out between last meeting and this one, how to come together. Mr. Rogers said he was very appreciative of that. He said Chairman Greenfield talked about the bipartisan support of Coroner Day, and isn't it wonderful to hear that word. He just really wanted to say he appreciated the board and the action they took. Sometimes topics are tough to deal with, but they all have to be willing and able to sit down and converse civilly. This was certainly a great example of that today. Mr. Rogers thanked them.

Abeer Motan: Ms. Motan spoke to the board about some of her concerns.

## **OFFICEHOLDER, DEPARTMENT HEAD & EMPLOYEE COMMENTS:**

Mark Scranton: Mr. Scranton said he is doing something that was near and dear to his heart that he has not been able to do for the last four years because of the health situation they were dealing with in all of their lives. He wanted to let the board know, and the community know that on Monday, September 11<sup>th</sup> he would be bringing back his 911 lunch. It will be a free lunch for all law enforcement and first responders, including fire fighters, and EMS personnel. He invited the community to come out and buy a lunch and support the first responders and law enforcement personnel. Mr. Scranton said he will be taking the money, as he did before, when the 911 memorial was done. He donated the proceeds from that particular lunch to help to pay for the transportation to bring the beam back to Decatur, Illinois. This time he would be taking the money and it would go toward scholarships for persons who want to pursue a paramedic career or EMT career through some programs at Richland.
