# **PUBLIC COMMENT:**

Abeer Motan: Ms. Motan spoke to the board regarding some of her concerns.

# OFFICEHOLDER, DEPARTMENT HEADS AND EMPLOYEE COMMENTS:

Mrs. Little: Mrs. Little just wanted to make the board aware that Dementia Friendly Decatur is an initiative that started about a year or so ago. It is part of a national global initiative to educate and increase awareness to the general public for signs of dementia and how to interact with people who have dementia. The ultimate goal is to make sure people living with dementia, and their caregivers, will always feel welcome in the community and stay active for as long as possible, because isolation is absolutely detrimental for people living with dementia. Mrs. Little said Dementia Friendly Decatur has been awarded the Governor's Award for Engaging Aging. IDOA will be doing an awards presentation later in November. She just wanted the board to be aware of that. Mrs. Little said there is also another citizen here in Decatur, Shirley Paceley, who will be getting the Senior Hall of Fame Award at the same award presentation.

Mr. Greenfield: Mr. Greenfield asked when that award presentation is.

Mrs. Little: Mrs. Little said November 28<sup>th</sup>. She will send an e-mail out to the County Board.

Mr. Yoder: Mr. Yoder wanted to briefly explain his position on the budget and taxes. He said he realized they had to have taxes. He stated that he is a realist. Mr. Yoder also

realizes that there are a lot of unfunded mandates being pressed down upon them from the state and other areas. He said they will work with that. He said he was unable to say anything at the Finance meetings because he was unable to attend all of those. He thinks they are spending a little more than they possibly could be due to the economy they are in. It could be due to rising salaries. There are a lot of demands, but there are a lot of demands on the taxpayers too. So, they have got to keep an eye out for them. That is really what they as a board are there for, to keep an eye on the budget. That is what he would like to do while he is here during his term. He knows there has been a lot of hard work on the budget. He knows a lot of folks work very hard for this county and he didn't want to insult them. He appreciates everything they do. Mr. Yoder said he sincerely hopes that in next year's budget going forward, they try to start reining in some of their excess costs whenever and wherever they can.
