# **BUDGET SESSION**

Jay A. Dunn Chairman Stephen M. Bean Clerk The Chairman called the meeting to order at 6:00 p.m. with the Sheriff and State's Attorney present.

The Roll Call showed all members present with the exception of Mr. Mattingley and Mr. Meachum.

#### **COMMENTS:**

Mr. Dunn: Mr. Dunn said before he asked for the opening prayer he wanted to make three comments. He said on their tables the board members should have a copy of a spread sheet from the Howard G. Buffett Foundation. He said if you want to discuss or comment on it please do so during officeholder remarks. The other issue involves America's Gold Star Families and an event that is coming up. Sid Palmer is here and just wanted everyone to know they are having this event in honor of his son. Mr. Dunn asked Sid to stand and told him they appreciated his son's service.

Sid Palmer: Sid Palmer lives at 4720 W. Cantrell Street. He said that since August 21<sup>st</sup> of last year when they were thrown into this new world, when you have a casualty that is active you become a Gold Star Member. This will be the third Christmas tree in the State of Illinois for the Gold Star Families. The first one was in Springfield for two years last year, which will now be in Peoria at the airport there. Ours will be at the Civic Center, which the dedication is going to be on the 29<sup>th</sup> and you are all invited. Mr. Palmer said he did not just want to drop off a piece of paper; he wanted it to be more personal than that. He said the third one is at the Bloomington airport. So, it will be the first year and hopefully it will be an ongoing thing.

#### **B. PROCLAMATIONS**

Mary Eaton presented the following Proclamation: Whereas, Stephen Bean has served as the Macon County Clerk since December 1, 1990 and ran for a total of 7 consecutive terms facing an opponent only twice, and Whereas Steve Bean became interested in politics as a child where he gives credit to the late Mr. Roy Anthony, and therefore became very active in local and state politics resulting in him being chosen the youngest Democratic Party County Chairman in the state, in the year of 1980, and Whereas Steve Bean served as an alternate delegate in Jimmy Carter's campaign for President and also prior to being elected as County Clerk he worked in state government for the offices of State Treasurer and State Comptroller, and Whereas Steve Bean has had a distinguished career in public service as a member of the Board of Health, Democratic Party Chairman, graduate and teacher at Richland Community College and received many outstanding awards over the years, and Whereas Steve Bean is a diehard St. Louis Cardinal fan and a hardcore Star Trek fan and is the only candidate that regularly had his dog with him in the Labor Day Parade even pulling the dog in a wagon when the dog was too old to walk, and Whereas Steve Bean has always been extremely considerate of others and performed countless little acts of kindness for which he seeks no acknowledgement and has more often than not, sacrificed his personal interests or pursuit of activities of interest in order to do his job at the level he has set for himself and for this his time in office will serve as the template for dedicated service to which his successors in that office, and all other offices will aspire, and now therefore be it proclaimed that Steve Bean has served with distinction in his 28 years of service to Macon County citizens and all fellow officeholders, and be it further proclaimed by this county board of Macon County that we recognize Steve Bean for his 28 years of public service both to Macon County and its residents.

Tom Schneider: Mr. Schneider said that is a tough act to follow and congratulated Steve. Mr. Schneider presented the following Proclamation: Whereas, Howard Graham Buffett began his career on August 12, 2012 as an Auxiliary Deputy Sheriff in the Macon County Sheriff's office and voluntarily served the citizens of Macon County until September of 2014. Whereas Howard Graham Buffett was appointed to the position of Under Sheriff working as a top administrator with the sheriff's office overseeing special projects, and Whereas Howard Buffett was sworn in the Macon County Sheriff on September 15, 2017 served as a Macon County Sheriff until December 1, 2018, and Whereas Howard Graham Buffett served his term as sheriff in a distinguished manner that served all citizens of

Macon County during his term as sheriff Howard Graham Buffett implemented programs that saved lives, automated the sheriff's office to streamline operations and improve officer safety, created a work environment that increased employee morale and established community relations that was inclusive to all people in the Macon County community. Now therefore be it proclaimed that Sheriff Howard Graham Buffett has served the citizens of Macon County with distinction, and be it further proclaimed that the County Board of Macon County recognize Sheriff Buffett for his service to Macon County and all of its citizens.

Howard G. Buffett: Mr. Buffett said, one word Mr. Chairman, ambushed.

Mr. Dunn: Mr. Dunn said that when Howard asked him if he would appoint him as sheriff, he asked Howard if he knew anything about the jail system and many hundreds of thousands of dollars later he thinks Sheriff Buffett has a pretty good grasp on it. Mr. Dunn said he and Macon County should thank him for that because he has really restructured the jail and the medical treatment there and everything else. Mr. Dunn said he appreciated that.

# PRESENTATION OF THE ANNUAL APPROPRIATIONS BUDGET FOR DECEMBER 1, 2018 THROUGH NOVEMBER 30, 2019

#### **COMMENT:**

Mr. Greenfield: Mr. Greenfield said he would like to thank everyone on the Finance Committee and Chairman Dunn. It has been a tough year and unfortunately next year is going to be tougher. His comment would be to officeholders and county employees, it is not going to be a fun year. This year we are about \$1,500,000 or \$1,400,000 in the red. We are fortunate enough that we have reserves to make up for that. We can't keep operating that way. So, in the next few years we are going to have to make some serious cuts unfortunately, unless we can figure out another revenue source. Anybody that has any ideas, our ears are open; we want to hear them.

14. Mr. Greenfield presented Resolution B-1-11-18 which is establishing the budgets for 2018-2019 fiscal year.

Mr. Smith: Mr. Smith asked what that meant.

Mr. Dudley: Mr. Dudley said all that does is zero out one line and move it to another.

Mr. Smith: Mr. Smith asked what budget it is in.

Mr. Dudley: Mr. Dudley said it is a highway line. It is Uniform/Safety Equipment and we are moving it to the Miscellaneous All Funds General Account.

Mr. Dunn: Mr. Dunn asked what the reason was for that move.

Mr. Baggett: Mr. Baggett said there is \$30,000 expense in our current expense in the Display Budget in that line item for uniforms. We are wanting to zero that uniform line item out as an affirmative action of the county board basically saying that is not going to be in that line item and move that to the miscellaneous line item below. That is the purpose of the amendment.

Ms. Dawson: Ms. Dawson asked why it was being moved.

Mr. Baggett: Mr. Baggett said because we have a.... He asked Mr. Bird how he wanted to describe it.

Bruce Bird: Mr. Bird said if we have it in the miscellaneous line item it is going to be a little bit easier to handle any kind of payments that we have out of there going forward. It is just an easier way of handling it. There is no change in the budget. It is basically just taking one out of one and putting it in the other.

Mr. Dunn: Mr. Dunn asked Carol Reed if she was ok with that and she replied yes.

Mr. Tanner: Mr. Tanner said he could get the number, but he doesn't have a percentage. He could get it for him tomorrow.

#### **CITIZENS' REMARKS:**

Dan Cooley: Mr. Cooley lives at 5911 Hogan Road in Dalton City, IL. He wanted to thank Chairman Dunn and the board for hearing our request for this resolution. He was not going to reiterate all of the points he has made to them over the past few months. Mr. Cooley was sure they were tired of seeing him in their e-mail in box, but we want to make everyone aware of what is going on. He did want to point out something that probably needs more attention than it did originally for the mere reason of the change in Springfield that has just happened. Our new governor is going to be very much anti-gun. He has already said so, and has already proposed 100% tax on all firearms and that will impact Macon County in the tax structure to some degree. There are laws that he would like to see implemented that have been blocked previously. So, we are going to be in for this whole fight all over again that we successfully avoided last year with just a couple different things that did pass. We are not opposed to all gun legislation, but there is a lot

of it out there that doesn't serve well for any of us. The thing he would like to point out to everyone is that this was put on a ballot referendum in 17 different counties this past election. In all 17 counties it was passed. Mr. Cooley said that brings it to a total of about 54 counties that have signed on to this resolution in one form or another. As Jay pointed earlier, this was not near as binding or profound as some of them. But, it does give the message to Springfield that we are interested in this issue and we don't want to see any other erosion of the Second Amendment. That is all we are asking of the board, to represent us as individuals and give a bigger voice to the government in Springfield that we don't want to see any more erosion of the Second Amendment and no further gun laws that prevent us from protecting our family in the home or in the public, wherever it might be. It dawned on him as he was thinking about it, this is a government building and as much as law enforcement knows, we can't carry in here. So, he said he locked his gun up like the lawful citizen he tends to be and all of the rest of the folks in here did as well. We did that. The criminals won't do that; they will come right on in here if they want to and pay no attention to any of those laws. So, they do absolutely no good. The prohibited places to carry do no good as well because law abiding citizens are going to stay law abiding. Mr. Cooley appreciated their consideration and interest on all of this and attention to it.

French MacLean: Mr. MacLean lives at 9 Montgomery Place in Decatur. He is a retired Colonel of Infantry in the Army. He went to West Point and graduated in 1974 and served 34 years in. During his time in, he commanded about 3,000 soldiers and 2,900 were armed with fully automatic weapons. He was not talking media fully automatic. He was talking rock-n-roll empty the magazine spray and pray. He said another 100 were armed with pistols. One person was not; he was the chaplain and he depended on them to take care of him. Not one time in the 34 years did one of those soldiers armed with a weapon turn on another soldier. He said what that taught him was that it is the person behind the machine and if you have good, responsible people it doesn't matter if it is a gun or a bus or a train or a plane; you are going to be ok. Mr. MacLean said if his people behind his machines are better than your people, he wins. It is a red, white and blue issue. The second thing is that when he was a Second Lieutenant a Colonel came up to him and said, "Lieutenant never give an order to your platoon that you know they will disobey." He thought that was kind of odd and was not what they taught them at West Point. That Colonel said the reason is, if you give that order and then they disobey then you either have to punish each and every one of them or you have to resign because you have lost control of that platoon. Either way, the Army suffers. So, what you have to do with an order is convince them that it is moral to do before you give the order or they will view it as a non-moral order and they will not follow it. So, whether we are talking about Second Amendment or First Amendment, any of the amendments; before we pass a law to change one of the amendments we have to look at what happens if the people view our law as amoral. They will not follow it. We tried it for prohibition a hundred years ago and we created 100,000,000 people who were criminals who said nobody tells me when I can have a beer or not. So, you are the lawmakers and before you make any changes to an amendment, look at whether the people are going to view your change as a moral change or as an immoral change. Then go ahead and do what you have to do.

#### **OFFICEHOLDERS' REMARKS:**

Mr. Dudley: Mr. Dudley said he would like this board and the people in this chamber to please keep the family of our former Sheriff Thomas Schneider's family in their thoughts and prayers. His wonderful sister passed away after a long battle with cancer. She was a wonderful young lady and really loved her brother.

Mr. Oliver: Mr. Oliver said he was very happy that the note that we got from Mr. Buffett was presented. He hopes the members of the board realize that Mr. Buffett has been a man of integrity and someone who has done so much for this community. He wanted to personally thank Mr. Buffett for the many contributions he has brought to the city and this county. The things he has done for this community are going to be sorely missed, not only from the standpoint of law enforcement but also humanitarian causes. Mr. Oliver said his concern was what would happen when Mr. Buffett left. These things that have been going on for so long seem to almost have been taken for granted that we were going to have this forever. He wanted to know what the responsibility was going to be left to us to take care of these programs. He said that Mr. Buffett explained it very well and he hoped everyone would get to see this and know it is not a flash in the pan. It is going to be something that should be lasting and we will be able to take care of after he is gone. We will invite Mr. Buffett back again to see how it is going and if we do need some more help we would call on him. Mr. Oliver thanked Mr. Buffett.

There was no old business presented at the meeting.
