# Macon County Board Resolution Approving Intergovernmental Delegation Agreement between the Illinois Environmental Protection Agency and Macon County

Ms. Rasmus reported that since the 1990's the department's enforcement program has been under two separate agreements with the Illinois Environmental Protection Agency. These were a delegation agreement along with a grant agreement. Now, the IEPA has changed formats and for the state's FY2017 and beyond, each participating county will be under a single intergovernmental agreement. This single agreement includes both the delegation of authority and

the funding mechanism for the enforcement program. This agreement has been reviewed by Mr. Baggett with the State's Attorney's Office.

Mr. Bird made a motion to approve forwarding to the full board with recommendation for approval, seconded by Mr. Noland.

Mr. Minich asked if there were any substantial changes. Ms. Rasmus said no, this is a format change where the IEPA wanted to take the two documents and merge them into one for all of the counties. Mr. Minich said that they would then continue to provide about 70% of the funding and we will continue to do what we do, but they will be the authority that tells us what to do. Ms. Rasmus confirmed that Mr. Minich was correct.

The motion carried 7-0.

# Health Department- No Report

#### Animal Control

Ms. Horton distributed the May report and informed the members that the 10 year anniversary open house had been held a couple of weekends ago. At the last minute, it was moved indoors and everyone had a really good time. There were about 10-12 adoptions that day. It is now kitten season and there are probably over 100 currently at the shelter. 60 or more are at the shelter and probably at least that many in foster care that are not yet old enough for adoption. This year has hit harder than the two previous years. For \$75, kittens that have been spayed / neutered, micro-chipped, had leukemia tests, rabies vaccine & all other appropriate vaccines can be adopted.

Chair Dudley commented that he had attended the 10<sup>th</sup> anniversary open house and they had done a great job. He expressed appreciation to everyone that helped with it and said it was a great event.
