Animal Control

Ms. Horton distributed the monthly report. She announced that they would be having the birthday party for the dogs this weekend and Christmas in July fostering project also starts this weekend.

Veteran's Assistance - No report

Health Department –

Ms. Heyer reported that they are starting to help with car seat checks again. She said they had gotten out of it the last couple of years, but have started back up and will be working with Child Care Resource and Referral folks. There will be one on July 10 at the Fire Station #1 on North Water from 9 a.m. to 12 noon. People are asked to make an appointment. This is something that really needs to be done, so Ms. Heyer said they are going to get back to it.

Environmental Management –

Ms. Rasmus reported that as the county is moving forward to developing a new compost site, it has been seen as a conflict of interest for Ms. Rasmus and that department to be inspector and try to inspect the other two private facilities while we are trying to develop one. So, starting July 1, the IEPA will pick up the compost sites in Macon County and inspect those. An exchange of work had to be done, so, as part of that, the department will be inspecting some retail tire sites. Mr. Meachum commented that this is not the first time we've done that and that we used to inspect some tire sites prior to this. Ms. Rasmus said that is correct.

Ms. Rasmus went on to point out that this is Macon County's compost facility. It is not run by the county. It's Larry Garver's property, operated by Rex Evans. She referred to handouts and pointed out bags of landscape waste. The scale is 1 to 500. Referring to another handout on the Urbana site, she said this is what we want. This is the model site. Looking at the 1 to 500 scale on this one, one can see the difference of how much, the bags of waste, that is on the ground. The point is, that as the County is looking at developing a new compost site, it is going to be run according to regulations, it will be neat and clean, and we don't want to have a dumping

site. She said she really wanted them to see the stark difference in what we have now and what we would like to have. Mr. Meachum asked if she was willing to go over this on a one on one basis. Ms. Rasmus said absolutely. Ms. Kraft clarified that the first set of pictures was of Larry Garver's. Ms. Rasmus confirmed and stated that the aerials were taken in 2018. She repeated that their goal is to run the county site according to regulations, keep it kept up. It is not a dump, but is a compost site.
