CALL TO ORDER

The meeting was called to order by Chair Jackson at the Macon County Office Building.

APPROVAL OF THE MINUTES FROM PRIOR MEETING

Mr. Gresham made a motion to approve minutes of the 2/4/19 meeting, seconded by Ms. Zimmerman and the motion carried 5-0.

REPORTS

Audit Sub Committee -

Ms. Reed explained that the auditors were here in January and the first week of February. They have not been back here in a couple of weeks, but they are working off site and at other locations within the county.

Auditor -

Ms. Reed explained that the insurance committee had met this past week. We asked for a plan to hold or reduce costs and we think we have something that will work. She said she would be bringing it to the O&P Committee later this month and then it will come to the Finance Committee at the next meeting. She said the hope is that by tweaking a few things, the cost will be held steady or even be reduced a little bit. This is for the Blue Cross / Blue Shield health plan for the county employees. This is always a major thing that is worked on starting in February / March and then it renews July 1st.

Board of Review -

Ms. Fowler reported that they had met 2/28 and closed the Assessor Books for 2018. They are right on target to get those values turned over to the County Clerk on time in the next week or so.

GIS -

Ms. Fowler reported that they had hired a new Tax Mapping Specialist. She started 2/25. That is a huge relief. She is going through training on the office procedures and the Assessor's processes. She will start shortly on mapping maintenance. Chair Jackson asked if this is the person she had previously spoken about having hopes that they might get. Ms. Fowler said this is a recent graduate in December from ISU.

Supervisor of Assessments -

Ms. Fowler reported that the Chief Deputy position is still vacant. There are three applicants, but the job is still posted on the websites and she said she hopes to get a couple more. Interviews will start possibly next week.

This year is Decatur Township's Quad. That will be the only quad this year. That will give the office a chance to do a lot of clean up in the smaller townships with just permit work, picking up demolitions and new construction. The startup of the 2019 Assessment Cycle is beginning now. The townships that the office has to do the non-quad work for are Long Creek, Whitmore, Oakley and South Wheatland. That is very manageable.

Chair Jackson asked what the rollup looked like. Ms. Fowler said that would be coming shortly. A Freeze process is done and the numbers will be tallied by the end of the week. She said she would bring a report to the next meeting showing how it compares to previous years.
