## DUTIES OF VARIOUS OFFICES

### \*COUNTY BOARD

Macon County was organized under a township form of county government. The County Board is apportioned into seven (7) districts. Three board members are elected from each district. Currently, the board has twenty-one (21) members. The board chooses one of its members to serve as chairman for a two-year term at its organizational meeting in December following the General Election.

Every ten (10) years the county board shall reapportion Macon County so that each member represents the same number of inhabitants.

The Macon County Board is responsible for adopting all ordinances (laws) for governing Macon County; establishing budgets for the county funds as well as levying taxes therefore; and promulgating policies and regulations for the management of county operations.

The county board meets monthly on the second Thursday of each month. Committee meeting notices are posted in the county board's office on a weekly basis. Board room and offices are located on the fifth floor of the Macon County Office Building, Room 501.

### \*COUNTY CLERK

The County Clerk's Office has four major functions:

1. clerk of the County Board and keeper of the county records;
2. chief election officer for the county;
3. keeper of vital records including birth death, and marriage records; and
4. is responsible for computing tax rates and the redemption of delinquent taxes.

By law, the County Clerk files the commissions for notary public's, files assumed names for businesses, issues marriage licenses, and files statements of economic interest for Macon County. Additionally, the County Clerk's Office administers voter registration for all elections in Macon County.

The County Clerk's Office is located in the Macon County Office Building, first floor, Room 104.

#### \*COUNTY RECORDER

The Recorder is required to record all documents submitted by the public which are qualified to be recorded. Recorders are responsible for receiving, keeping, and indexing documents of many types, including mortgages, deeds, and other instruments conveying real estate. Certificates of release or discharge from U.S. Military services are recorded. The County Recorder's Office is located on the second floor of the Macon County Office Building, Room 201.

#### \*AUDITOR

The Auditor keeps all general accounting records of the County, reporting monthly on its financial position. In accordance with generally accepted accounting principles (GAAP), the Auditor's Office performs internal auditing functions relating to all claims against the county. The Auditor's Office is located on the third floor of the Macon County Office Building, Room 312.

#### \*STATE'S ATTORNEY

The State's Attorney is chief legal officer of the county, the public prosecutor and the attorney for the county itself. The State's Attorney's Office prosecutes all felony, misdemeanor and traffic cases filed in Macon County. The State's Attorney serves as legal counsel and advisor to the Macon County Board and all county officials.

The State's Attorney's Office is located on the fourth floor of the Macon County Court Facility at 253 E. Wood.

#### \*SHERIFF

The Sheriff is the chief law enforcement officer with county wide jurisdiction. The Sheriff's Office serves and executes documents of all descriptions, including warrants, process, orders, and judgments. The Sheriff serves as the custodian of the courthouse and county jail. The Sheriff's Office is located in the Decatur/Macon County Law Enforcement Center.

#### \*COUNTY TREASURER

The County Treasurer has the responsibility to receive, invest, and distribute the revenues and public monies of Macon County. The County Treasurer serves as County Collector whose duties include preparing bills and receipts for the purpose of tax collection of real estate, drainage and mobile home taxes within Macon County. Additionally, the Treasurer as County Collector holds an annual tax sale on every parcel that taxes remain unpaid.

The County Treasurer is responsible for recording of estate taxes. The Treasurer collects, transfers, and distributes monies from the state to various local taxing bodies.

The Treasurer's Office is located on the third floor of the Macon County Office Building, Room 302-303.

**\*CORONER**

The Coroner carries out investigations into certain types of deaths which were sudden, natural and violent in nature that appear to be accidental, homicidal or suicidal to determine the cause and manner of death.

The Coroner has the discretionary powers to hold Coroner's Jury inquests into the cause of death.

The Coroner's Office is located on the second floor of the Macon County Court Facility at 253 E. Wood.

**\*SUPERVISOR OF ASSESSMENTS**

The Supervisor of Assessments Office prepare and maintain tax maps, property record cards, and property ownership lists for all real estate in Macon County for purposes of real estate taxation. The Supervisor works with township assessors in making uniform assessments on the county real estate. Additionally, the Supervisor serves as the Clerk for the Board of Review. The Board of Review's duties include reviewing all assessments made by Township Assessors and hearing complaints on real property assessments.

The Supervisor assists senior citizens in filing for Real Estate Tax Exemptions.

The Supervisor of Assessments Office is located on the fourth floor of the Macon County Office Building, Room 401.

**\*CLERK OF THE CIRCUIT COURT**

The Circuit Clerk's Office has the statutory responsibility of receiving and filing all civil, criminal, probate, and traffic cases. The Circuit Clerk issues all processes such as citations, subpoenas, all witnesses for trial, notices and summons. The Circuit Clerk's Office collects all child support, traffic and criminal payments. The office is responsible for the selection of jurors. The office is part of the Sixth Judicial Circuit.

The office of the Clerk of the Circuit Court is located on the first floor of the Macon County Court Facility at 253 E. Wood.
