
# PROCEEDINGS OF THE MACON COUNTY BOARD

The Roll Call showed all members present with the exception of Mr. Horve, Mr. Mattingley, and Mr. Oliver.

# **PROCLAMATIONS AND RECOGNITIONS**

Sheriff Root: Sheriff Root said he wanted to present a Life Saving Award. On January 21, 2024 at approximately 2:04 a.m. Warrensburg Fire Protection was detailed to 145 N. Main Street in Warrensburg, Illinois to check the welfare of a female found unresponsive in a restroom. Deputies Justin Lilly and Jessie Owens Jr responded to the scene and upon arrival Deputy Lilly met with an off-duty fireman Robert Allen of Harristown Fire Department and off duty EMT Rebecca Evans of Latham Fire Protection District who were attending to the unconscious victim. Upon arrival, Deputy Lilly found fellow patrons Rebecca Evans and Robert Allen attempting to aid the victim. Assessing the situation, Deputy Lilly directed Evans to tilt the victims head back as he administered the first dose of Narcan which provided no effect to the victim. Several minutes later Deputy Owens arrived on scene with a second dose of Narcan which was administered and provided some effect to the victim. Shortly after, Police Chief Wheeler arrived at the scene and took command. Chief Wheeler is an EMT and responded with a third dose of Narcan and an AED. After administering the Narcan and hooking up the AED they monitored the victim until EMS arrived. Their quick thinking and decisive decisions played a critical role in saving a life that night. Their dedication and well-being toward others deserves recognition and it was with great pleasure they he presented them with a Life Saving Award. Sheriff Root said this community is grateful for their service and he was honored to present this award.

Grant Noland: Mr. Noland presented a Proclamation regarding National Agriculture Day which is recognizing and celebrating the contributions farmers and farm families have made to better the lives of citizens in their community.

Mat Muirheid: Mr. Muirheid, from the Macon County Farm Bureau, thanked the board and said it was greatly appreciated.

Mrs. Little: Mrs. Little invited Bob Archer to come forward. She presented a proclamation to him proclaiming the month of March of the year of 2024 be observed as DeMolay International Month saluting the young men of the Order of the DeMolay and expressing grateful appreciation for the fine example set by them in contributing to the welfare of the community by addressing themselves to the building of good character among the youth thereby aiding in the development of leadership for tomorrow.

Mr. Archer: Mr. Archer said DeMolay was brought into Decatur in 1933 and unfortunately went dark in 2004 because of lack of membership. He said at the end of 2021 they were able to bring the chapter back. They are starting to work inside the community doing civil service, fund raising, and teaching these young men how to be the next leaders of the generations to come.

offered. They have had very good feedback and she really appreciated their participation. She thinks it is excellent because the offices in this building especially, deal with all elements of the community and this should make it go better from both sides of the window.

Sherry Doty: Sherry Doty thanked Linda for what she was doing with the training class. She said it affects everyone and their families eventually, and is very important.

Mr. Greenfield: Mr. Greenfield asked them to keep Mr. Oliver in their prayers. He and Tammy visited him about a week ago. He was doing pretty well and was giving them a hard time, so he thinks that means he is getting better. They looked forward to him coming back.
