COUNTY DURING FY2019

#### **RESOLUTION NO. G-4983-04-19**

WHEREAS, the Office of the State's Attorneys Appellate Prosecutor was created to provide services to State's Attorneys in Counties containing less than 3,000,000 inhabitants; and

WHEREAS, the powers and duties of the Office of the State's Attorneys Appellate Prosecutor are defined and enumerated in the "State's Attorneys Appellate Prosecutor's Act," 725 ILCS 210/1 et seq., as amended; and

WHEREAS, the Illinois General Assembly appropriates monies for the ordinary and contingent expenses of the Office of the State's Attorneys Appellate Prosecutor, one-third from the State's Attorneys Appellate Prosecutor's County Fund and two-thirds from the General Revenue Fund, provided that such funding receives approval and support from the respective Counties eligible to apply; and

WHEREAS, the Office of the State's Attorneys Appellate Prosecutor shall administer the operation of the appellate offices so as to insure that all participating State's Attorneys continue to have final authority in preparation, filing, and arguing of all appellate briefs and any trial assistance; and

NOW, THEREFORE, BE IT RESOLVED by the Macon County Board, assembled in regular session this 11th day of April, 2019, at Decatur, that it does hereby support the continued operation of the Office of the State's Attorneys Appellate Prosecutor, and designates the Office of the State's Attorneys Appellate Prosecutor as its Agent to administer the operation of the appellate offices and process said appellate court cases for this County.

BE IT FURTHER RESOLVED that the attorneys employed by the Office of the State's Attorneys Appellate Prosecutor are hereby authorized to act as Assistant State's Attorneys on behalf of the State's Attorney of this County in the appeal of all cases, when requested to do so by the State's Attorney, and with the advice and consent of the State's Attorney, prepare, file, and argue appellate briefs for those cases; and also, as may be requested by the State's Attorney, to assist in the prosecution of cases under the Illinois Controlled Substances Act, the Cannabis Control Act, the Drug Asset Forfeiture Procedure Act and the Narcotics Profit Forfeiture Act. Such attorneys are further authorized to assist the State's Attorney in the State's Attorney's duties under the Illinois Public Labor Relations Act, including negotiations thereunder, as well as in the trial and appeal of tax objections.

**BE IT FURTHER RESOLVED** that the Office of the State's Attorneys Appellate Prosecutor will offer Continuing Legal Education training programs to the State's Attorneys and Assistant State's Attorneys.

**BE IT FURTHER RESOLVED** that the attorneys employed by the Office of the State's Attorneys Appellate Prosecutor may also assist the State's Attorney of this County in the discharge of the State's Attorney's duties in the prosecution and trial of other cases, and may act as Special Prosecutor if duly appointed to do so by a court having jurisdiction.

**BE IT FURTHER RESOLVED** that if the Office of the State's Attorneys Appellate Prosecutor is duly appointed to act as a Special Prosecutor in this county by a court having jurisdiction, this county will provide reasonable and necessary clerical and administrative support on an as-needed basis.

BE IT FURTHER RESOLVED that the Macon County Board hereby agrees to participate in the service program of the Office of the State's Attorneys Appellate Prosecutor for Fiscal Year 2019, commencing December 1, 2018, and ending November 30, 2019, by hereby appropriating the sum of \$24,000.00 as consideration for the express purpose of providing a portion of the funds required for financing the operation of the Office of the State's Attorneys Appellate Prosecutor, and agrees to deliver the same to the Office of the State's Attorneys Appellate Prosecutor on request during the Fiscal Year 2019.

#### LABORATORY SERVICES AGREEMENT

THIS LABORATORY SERVICES AGREEMENT ("Agreement"), effective as of the last date of signature below ("Effective Date"), is by and between St. Mary's Hospital, Decatur, of the Hospital Sisters of the Third Order of St. Francis, an Illinois not-for-profit corporation ("Hospital"), and Macon County Animal Control and Care Center ("Client").

#### RECITALS

- A. Hospital operates a fully accredited laboratory and performs various tests and examinations of material for the purpose of providing diagnosis, prevention or treatment of disease or the assessment of medical conditions.
- B. Client desires to have Hospital provide those certain laboratory services described in this Agreement on an independent contractor basis for Client, and Hospital desires to provide those services on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the above recitals and the mutual covenants contained in this Agreement, Hospital and Client agree as follows:

#### 1. TERM AND TERMINATION.

- 1.1 <u>Term.</u> This Agreement commences on the Effective Date and continues for an initial term of one (1) year ("Initial Term"). Thereafter, this Agreement shall automatically renew for successive one-year terms. The Initial Term together with each renewal term shall constitute the "Term" of this agreement.
- 1.2 Termination. This Agreement may be terminated as follows:
  - 1.2.1 <u>Termination by Agreement</u>. This Agreement may be terminated by mutual written agreement of the Parties.
  - 1.2.2 <u>Early Termination</u>. This Agreement may be terminated by either Party with or without cause or penalty by delivering written notice of termination to the other Party at least ninety (90) days prior to such termination.
  - 1.2.3 Termination with Cause. In the event either Party commits a material breach of any of the provisions of this Agreement, the non-breaching Party may terminate this Agreement upon thirty (30) days written notice; provided, however, that the breaching Party shall have the right to cure such breach within thirty (30) days after written notice of such breach and, if cured, this Agreement shall continue in full force and effect.

#### 2. COVENANTS AND DUTIES OF HOSPITAL.

- 2.1 <u>Services</u>. At Client's request, Hospital shall perform those following services at a generally acceptable and recognized professional level of quality when it receives a blood, serum, tissue or other specimen (a "Specimen") from Client ("Laboratury Services"):
  - 2.1.1 Laboratory testing services;
  - 2.1.2 Reference laboratory testing services;
  - 2.1.3 Courier service for Specimens at an agreed upon schedule, and
  - 2.1.4 Ongoing customer service through sales and service visits.
- 2.2 Best Efforts. Hospital shall exercise its best efforts to provide Laboratory Services without unnecessary delays or suspension of services. However, it should be recognized that some circumstances may be above and beyond the control of Hospital. Therefore, it is understood that this Agreement shall be construed as a "best effort" Agreement.
- Reports. Hospital shall provide Client with a written report of the results of the Laboratory Services provided pursuant to this Agreement. All such reports shall be transmitted to Client via agreed upon means. In addition, Hospital shall call Client directly with test results upon Client's written request for such service.

#### 3. PAYMENT TERMS

- 3.1 Billing. Hospital shall bill and collect from Client directly, as appropriate, for client account testing in accordance with Hospital's standard fee structure at the rates set forth in Exhibit A (the "Fee Schedule"), attached hereto and incorporated herein. The rates set forth in Exhibit A may be updated from time to time by Hospital, but not more often than once annually, upon thirty (30) days prior written notice to Client.
- 1.2 <u>Invoices</u>. Hospital shall send Client an itemized invoice each calendar month ("Invoice") for Laboratory Services for which test results were reported during the prior month. Client shall pay these Invoices within thirty (30) days of receipt of invoice.

#### 4. COVENANTS AND DUTIES OF CLIENT.

4.1 Specimen Handling and Requests. Client shall ensure that Specimens provided to Hospital are handled in accordance with commonly accepted pathology specimen handling protocols, such as those set forth in the Accreditation Manual for Pathology and Clinical Laboratory Services of the Joint Commission or other policies and procedures as may be reasonably set forth by Hospital from time to time.

4.2 <u>Supplies</u>. Client agrees that all items, devices, or supplies furnished to it by Hospital for the purposes of Specimen collection and analysis pursuant to this Agreement ("Supplies") shall be used solely to collect, transport, process, or store specimens for Laboratory Services provided by Hospital pursuant to this Agreement.

#### 5. RECORDS.

5.1 Ownership of Records and Specimens. All business records and information relating exclusively to the business and activities of either party is the property of that party, irrespective of the identity of the party responsible for producing or maintaining such records and information. Any and all records, charts or reports produced by Client are and remain the property of Client. Any and all records, charts or reports produced by Hospital are and shall remain the property of Hospital. Hospital shall acquire ownership of all specimens or samples which it examines or reviews on behalf of Client. The provisions of this Section 5.1 survive the expiration or termination of this Agreement.

#### 6. COMPLIANCE/ STANDARDS.

- 6.1 Ethical and Religious Directives. The parties acknowledge that Hospital is operated in accordance with the Ethical and Religious Directives for Catholic Healthcare Services as promulgated, from time to time, by the United States Conference of Catholic Bishops, Washington, D.C., of the Roman Catholic Church ("Ethical and Religious Directives"), and that the principles and beliefs of the Roman Catholic Church are a matter of conscience to Hospital. It is the intent and agreement of the parties that neither this Agreement nor any part hereof shall be construed to require Hospital to violate said Ethical and Religious Directives in its operation and all parts of this Agreement must be interpreted in a manner that is consistent with said Ethical and Religious Directives.
- 6.2 Compliance with Laws, Regulations, and Accreditation. The parties believe and intend that this Agreement complies with all applicable federal and state laws as well as applicable regulations and accreditation standards, including but not limited to Federal Health Care Program as defined under 42 U.S.C. § 1320a-7b(f), fraud and abuse laws (including the Anti-Kickback Statute and the Stark Law), the Medicare Conditions of Participation, the Clinical Laboratory Improvement Amendments, laboratory accreditation and certification requirements, applicable generally accepted clinical laboratory testing standards, and all of the rules and regulations promulgated pursuant to, and all of the cases or opinions interpreting such statutes and laws (collectively, "Laws").

#### 7. GENERAL PROVISIONS

7.1 <u>Amendments</u>. This Agreement may be amended only by an instrument in writing signed by the parties.

- 7.2 Assignment. Neither party may assign this Agreement or the rights or obligations hereunder without the specific written consent of the other party, except that this Agreement may be assigned by Hospital without the prior written approval of Client to an affiliate of Hospital. For purposes of this Agreement, "affiliate" shall mean any successor entity of Hospital, or any entity controlled by Hospital or Hospital Sisters Health System.
- Books and Records. If this Agreement is a contract within the purview of Section 1861(v)(1)(1) of the Social Security Act (Section 952 of the Omnibus Reconciliation Act of 1980) and the regulations promulgated at 42 C.F.R. Part 420 in implementation thereof, the parties agree to make available to the Comptroller General of the United States ("Comptroller General"), the Secretary of the Department of Health and Human Services ("Secretary") and their duly authorized representatives, for four (4) years after the latest furnishing of services pursuant to this Agreement, access to the books, documents and records and such other information as may be required by the Comptroller General or Secretary to verify the nature and extent of the costs of services provided by each party, respectively. If either party, upon the approval of the other party, carries out the duties of this Agreement through a subcontract worth \$10,000.00 or more over a twelve (12) month period with a related organization, the subcontract will also contain an access clause to permit access by the Secretary, Comptroller General and their representatives to the related organization's books and records.
- 7.4 Counterparts. This Agreement and any amendments thereto may be executed in counterparts on behalf of Hospital and Client. Each copy shall be deemed an original, but all originals together constitute one and the same instrument.
- 7.5 Entire Agreement. This Agreement supersedes all previous contracts or agreements between the parties for Laboratory Services, and constitutes the entire agreement between the parties. Neither Hospital nor Client shall be entitled to benefits other than those specifically enumerated herein.
- 7.6 Governing Law. This Agreement shall be construed and governed by the laws of lillinois.
- 7.7 Headings. The headings and subheadings in this Agreement are inserted for convenience of reference only and shall not affect the meaning or interpretation of this Agreement.
- 7.8 Indemnification. Each party agrees to indemnify and hold the other harmless from any and all claims, suits, damages, fines, penalties, judgments, liabilities and expenses (including reasonable attorney's fees and court costs) arising from (i) any negligent or willful act or omission of the party, its agents, or employees; (ii) breach of this Agreement; or (iii) violation of a Law. Notwithstanding anything to the contrary in this Agreement, a party's obligations with respect to indemnification for acts described in this Section shall not apply to the extent that such application would nullify any existing insurance coverage of such party or as to that portion of any claim of loss in

- which an insurer is obligated to defend or satisfy. This Section 6.8 shall survive the expiration or earlier termination of this Agreement.
- 6.1 <u>Independent Contractors</u>. In performing the Laboratory Services, Client and Hospital are acting as independent contractors and not as agents or employees, and are contracting with each other solely for the purpose of carrying out the terms and conditions of this Agreement.
- 6.2 <u>Interpretation</u>. The parties hereto acknowledge that each party has reviewed the terms and provisions of this Agreement and such terms and provisions shall be construed fairly as to all parties hereto and not in favor or against any party, regardless of which party was generally responsible for the preparation of this Agreement.
- 6.3 Master List. This Agreement shall be included in Hospital's master contracts database (the "Master List"). The Master List shall be maintained and updated by Hospital, and shall be available for review upon request by the Secretary.
- Notice. Notices or communications herein required or permitted shall be given to the respective party by registered or certified mail (each notice being deemed given as of the date of mailing) or by hand delivery at the address listed under the party's signature to this Agreement unless either party shall designate a new address by written notice. The notice shall be deemed to be received as follows: in the case of actual delivery, on the date of its receipt by the party entitled to it; in the case of overnight courier service, on the next business day following mailing; and in the case of certified or registered mail, three (3) days after the date of its mailing.
- 6.5 Severability. If any term, covenant, or condition of this Agreement or the application thereof to any person or circumstance shall be invalid or unenforceable, then the remainder of this Agreement and the application of any term or provision to any person or circumstances, other than those to which it is held invalid or unenforceable, shall not be affected thereby and all other terms shall be valid and enforceable to the fullest extent permitted by law.
- 6.6 Third Party Rights. Except as otherwise expressly stated herein, the parties do not intend to create any enforceable rights in any third party under this Agreement and there are no third party beneficiaries to this Agreement.
- 6.7 Waiver of Breach. The waiver by either party of a breach or violation of any provision of this Agreement shall not operate as nor be construed to be a waiver of any subsequent breach hereof.

MACON COUNTY BOARD RESOLUTION AUTHORIZING SALE OF CERTAIN PARCELS OWNED BY THE COUNTY OF MACON PURSUANT TO TAX DEED FORECLOSURES TO THE CITY OF DECATUR

Resolution No. G-4988-04-19

WHEREAS, the County of Macon (County) became the legal owner of various parcels of land pursuant to the tax deed foreclosure process found in the Property Tax Code (35 ILCS 200/1-1 et seq.); and

WHEREAS, the County attempted to sell said parcels at auction on at least one, but in many cases, several public auctions; and

WHEREAS, to date, none of said parcels have been purchased at auction by private or other purchasers; and

WHEREAS, the City of Decatur (City) has reached out to the County to determine if the County is interested in selling said parcels to the City at less than the normal minimum bid if the City agrees to pay for and take ownership of all said parcels; and

WHEREAS, the City's purpose is to use its ownership of the parcels as part of its revitalization and beautification projects within the City's boundaries; and

WHEREAS, the City's ultimate goal is to return said parcels to the tax rolls, increasing tax revenues for both the City and County as well as the various taxing districts that would be impacted; and

WHEREAS, the City and County have determined that said parcels, due to their history of failing to sell for the minimum bid price at previous auctions, are unlikely to sell at the minimum bid price in future auctions, which will result in said parcels continuing to be left vacant, derelict and off of the tax roles for the City, County and the various taxing districts; and

WHEREAS, the County has determined that while it is not in the public interest to adopt a general policy of lowering minimum bid prices when properties do not sell at auction, the circumstances here are unique in that the City is offering to purchase more than 700 parcels at once and has a plan to use its new ownership to revitalize the community.

NOW THEREFORE BE IT RESOLVED by the Macon County Board, assembled in regular meeting at Decatur, that because of these unique circumstances, the County agrees to sell to the City the said parcels at less than the minimum auction bid price and to sell said parcels to the City for the price of \$75.00 per parcel.

BE IT FURTHER RESOLVED that the County shall convey its ownership interest to the City of the parcels set forth on the attached Exhibit A, subject to any limitations of or defenses to its ownership interest, upon the City's payment to the County of \$75.00 per parcel.

**BE IT FURTHER RESOLVED** that the Chair of the County Board, the State's Attorney, or their designees, are authorized to execute any documents necessary to complete conveyance of said parcels to the City.

**BE IT FURTHER RESOLVED** that this Resolution shall take effect immediately upon passage.

#### ORDINANCE NO. 2019-13

## ORDINANCE AUTHORIZING ACCEPTANCE OF CERTAIN PROPERTIES OF MACON COUNTY TRUSTEE FOR PUBLIC PURPOSE

WHEREAS, the City ("City") and County of Macon ("County") are units of local government as defined by Article VII, Section 1, of the Constitution of the State of Illinois; and,

WHEREAS, the City and County are authorized and empowered by Article VII, Section 10 of the Constitution and the Intergovernmental Cooperation Act (5 ILCS 220/1 et. seq.) to enter into Intergovernmental Agreements; and,

WHEREAS, the County owns various parcels of land pursuant to the tax deed foreclosure process found in 35 ILCS 22/1-1 et. seq. more particularly described in Exhibit A and Exhibit B attached hereto; and,

WHEREAS, the County has attempted to sell these parcels at various public auctions and there remain many parcels that have not been purchased at these public auctions; and,

WHEREAS, the City is a municipality with territory located wholly within the County; and,

WHEREAS, the City desires to improve, revitalize and redevelop its neighborhoods and community and has determined that the properties owned by the County are an important portion of said improvement, revitalization and redevelopment with the goal to return the properties and parcels owned by the County to the tax rolls thus increasing the tax revenues for the City, County and various taxing districts; and,

WHEREAS, the County has previously agreed to transfer under certain conditions the properties set out in Exhibit A to the City and the City has previously agreed to accept the properties under certain conditions.

WHEREAS, the City desires to purchase additional properties acquired by the County pursuant to the tax deed foreclosure process set out in Exhibit B, and the County has indicated its agreement to said purchase.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DECATUR, ILLINOIS:

Section 1. That the City declares that it is necessary and convenient for it to use, occupy and/or improve the property owned by the County as more particularly set out in Exhibit A and Exhibit B for the making of public improvements and for the public purpose of improving, revitalizing and redeveloping the City.

Section 2. That the properties shall be transferred upon such terms as previously agreed upon by the parties.

# MACON COUNTY BOARD RESOLUTION ESTABLISHING CIVIL FEES TO BE CHARGED BY THE CLERK OF THE COURT

#### Resolution No. G-4989-04-19

WHEREAS, the Illinois General Assembly passed comprehensive legislation in 2018 which completely overhauls the civil fee structures in the circuit courts throughout the State of Illinois; and

WHEREAS, the purpose of the legislation was to consolidate fees into unified schedules for all counties, to realign fees to be constitutional, and to provide for fee waivers for low income individuals; and

WHEREAS, effective July 1, 2019, Section 27.1b of the Clerks of Courts Act, 705 ILCS 105/27.1b, sets out the fees to be charged in all counties in the State of Illinois by the Clerks of the Circuit Court for the filing of pleadings and for other services provided by the Clerks in civil cases; and

WHEREAS, Section 27.1b of the Clerk of Courts Acts creates four schedules for civil filing fees, and three schedules for civil appearance fees, and establishes various other fees that Clerks of the Circuit Court are authorized to assess in civil cases, all of which are generally classified as "not to exceed" amounts; and

WHEREAS, Section 27.1b provides that, unless otherwise specified, the amount of the fees shall be determined by ordinance or resolution of the county board and remitted to the county treasurer to be used for purposes related to the operation of the court system in the county; and

NOW, THEREFORE, BE IT RESOLVED that commencing on July 1, 2019 the Clerk of the Circuit Court in Macon County shall charge and collect the newly established Civil fees and Criminal and Traffic Assessments as follows:

Civil fees shall meet the requirement of Section 27.1b of the Clerks of Courts Act, 705 ILCS 105/27.1b,

Fees in civil matters shall be assessed and distributed as set forth herein, in compliance with Section 27.1b of the Clerk of Courts Act, 705ILCS 105/27.1b

#### ORDER

The Access to Justice Act ("Act") (705 ILCS 95/1 et seq.) was enacted in 2013 with the goal of improving meaningful access to legal information, resources and assistance for all litigants, regardless of their income or circumstances. The Act established the Statutory Court Fee Task Force ("Task Force"), a bipartisan, multi-cameral coalition of stakeholders convened to study the current system of fees, fines and other court costs (collectively, "assessments") imposed upon civil and criminal litigants. The Task Force was charged with proposing recommendations to the Supreme Court and the General Assembly to simplify the imposition, collection and distribution of these assessments while making them more transparent, affordable, and fair.

After many months of study, the Task Force released its Report and Recommendations in 2016, which adopted five core principles:

- 1. Courts should be substantially funded from general government revenue sources. Court users may be required to pay reasonable assessments to offset a portion of the cost of the courts borne by the public-at-large.
- 2. The amount of assessments should not impede access to the courts and should be waived, to the extent possible, for indigent litigants and the working poor.
- 3. Assessments should be simple, easy to understand, and uniform to the extent possible.
- 4. Assessments should be directly related to the operation of the court system. Assessments imposed for a particular purpose should be limited to the types of court proceedings that are related to that purpose. Monies raised by assessments intended for a specific purpose should be used only for that purpose.
- 5. The General Assembly should periodically review all assessments to determine if they should be adjusted or repealed.

In response to the Task Force's recommendations, the General Assembly enacted Public Act 100-0987 which streamlines the current statutory fee provisions into a framework of fee schedules identifying the maximum amounts which can be assessed in each civil case category established by this Order.

In the coming months, the county boards will implement, by ordinance, the local fee amounts according to these new schedules. Before setting fees, county boards are strongly urged to review the five core principles outlined by the Task Force and to carefully consider the role and purpose of assessments in funding the justice system, as well as the relationship between assessments and access to justice.

#### THEREFORE, IT IS ORDERED that:
