He said they would basically be waiving those liquor license fees because of COVID. One is issued to the DAV and the other is issued to the New Back Door.

Dr. Zimmerman: Dr. Zimmerman asked what the cost was for the license. She was told it is \$1,200.00 (it is actually \$1250.00) plus a \$55.00 clerk fee.

Mr. Oliver: Mr. Oliver asked is those licenses are issued to an address or to a person.

Mr. Tanner: Mr. Tanner said they are issued to an address. They are issued to the location of the business.

Mr. Coleman: Mr. Coleman asked if the reason for doing this is to ease the economic burden due to COVID.

Mr. Greenfield: Mr. Greenfield said yes due to COVID.

Dr. Zimmerman: Dr. Zimmerman said she knows there were restrictions on how they can use the money. She just wondered, because it is mentioned in the resolution, if they

are not specifically using the money to cover it, but that in general the county has the money. She asked if that was correct. She said she was kind of confused by the wording.

Mr. Greenfield: Mr. Greenfield said the way he interpreted it was that the county was just waiving the normal liquor license fee the applicant would pay the county.

Dr. Zimmerman: Dr. Zimmerman asked if it was correct that the county was not taking any of their rescue plan money and saying it covered that.

Mr. Greenfield: Mr. Greenfield said that was correct.
