Mr. Wolfe: Mr. Wolfe said this is really inexpensive, and they do everything. They are the only company around here who do it.

Jerry Andrews: Mr. Andrews spoke to the board regarding changing hours at the Health Department, training they will provide to those who spray for mosquitoes, and health screenings the Health Department will provide.

Mr. Dudley: Mr. Dudley said he will be broadcasting live at the health screening function for WEJT.

Mr. Oliver: Mr. Oliver asked if County Board members are members of the Chamber of Commerce and eligible for the discounted gas card being offered.

Tara Jaukkuri: Mrs. Jaukkuri said County Board members are eligible for the gas card, but it can only be used at Marathon gas stations.

Mr. Sampson: Mr. Sampson said they have hired a GIS Coordinator who will start work July $1^{\text {st }}$. It has been a tough couple of weeks for public service. Mayor Paul Osborne is a good man and will be missed. He also commented on the death of Dutch Lichtenberger and how much he will be missed. Mr. Sampson said Sheriff Dawson will be retiring in August and he will miss him. Sheriff Dawson is responsible for the stewardship of the LEST funds, and Mr. Sampson appreciated all of his hard work. With the retirement of Judge Greanias, Mr. Sampson said one thing that stands out is the judge's fairness. He was always fair with the County Board and with the citizens. He was an important part of the climbing out of the budget hole. Judge Greanias was always a man of his word. He was always civil, even when others were not.
