Mr. Bird: Mr. Bird said it is not necessarily an overrun. He had an original resolution about 4 years ago to cover the match and that is how much the cost of bridges has gone up in 4 years.

Mr. Greenfield: Mr. Greenfield asked which bridge it is.

Mr. Bird: Mr. Bird said this is the north bridge.

Mr. Drobisch: Mr. Drobisch asked when this would all be completed and open.

Mr. Bird: Mr. Bird said sometime within the next month.

Mr. Greenfield: Mr. Greenfield asked if that would be both of them.
