### **ZONING/SUBDIVISIONS**

1. Mr. Dudley presented Resolution Z-1128-12-13 which is regarding Case S-02-11-13, a petition submitted by Andrew Chiligiris, Trustee for a Special Use Permit to operate a daycare in R-1 Single Family Residential District on property commonly known as 3363 Nancy Road in South Wheatland Township. Staff recommended at hearing that the petition be approved with 6 stipulations. After hearing the evidence, the Zoning Board of Appeals voted 6-0 in favor of recommending to the County Board that the petition be approved with 6 stipulations. The EEHW Committee met and reviewed the petition and recommended by 5-0 vote that the County Board approve the subject petition with the 6 stipulations recommended by the Zoning Board of Appeals.

Mr. Dudley moved, seconded by Mr. Hogan to approve Resolution Z-1128-12-13 by prior roll call vote.

There were no questions or comments from the board floor.

### MOTION CARRIED.

2. Mr. Dudley presented Resolution Z-1129-12-13 which is regarding case S-03-12-13, a petition submitted by Twin Forks Wind Farm for a Special Use Permit to construct an electrical substation for electrical lines for an approximately 200 MW wind farm in A-1 Agricultural zoning on property commonly known as 12622 Glasgow Road in Austin Township. Staff recommended at hearing that the petition be approved with 5 stipulations. After hearing the evidence, the Zoning Board of Appeals voted 5-0 in favor of recommending to the County Board that the petition be approved with 5 stipulations. The EEHW Committee met and reviewed the petition and recommended by a 6-0 vote that the County Board approve the subject petition with the 5 stipulations recommended by the Zoning Board of Appeals.

#### MOTION

Mr. Dudley moved, seconded by Mrs. Cox to approve Resolution Z-1129-12-13 by prior roll call vote.

# **QUESTIONS:**

Mr. Ashby: Mr. Ashby asked if we got any other bids or quotes on this project, or other people interested in this project.

Kathy Hans: Mrs. Hans said she lives at 5602 W. Duroc Road in Maroa. She is just here for questions. This is her first time at a zoning committee so she doesn't know the protocol. She is concerned about the noise, and knows there are lawsuits in Champaign and Vermilion County. She just wants to know if the committee is doing their own research on that.

Mr. Drobisch: Mr. Drobisch said it has already passed the Zoning Board of Appeals. This is for the full board to vote on, so it has already passed the Zoning Board of Appeals.

Mrs. Hans: Mrs. Hans said she understands that, but wanted to know if they had done a study on the noise.

Mr. Drobisch: Mr. Drobisch said he had no idea whether they had or not.

Mr. Greenfield: Mr. Greenfield said this is not on the wind farm itself; it is for the electrical substation.

Mrs. Hans: Mrs. Hans said the substation, based on where it could be placed, could be ½ mile or 1/8 of a mile; it would be within a mile of her house. She asked about the substation noise. There was no response. Mrs. Hans said, so there hasn't been a study.

Mr. Williams: Mr. Williams said he didn't think we routinely do studies for substations. We have approved several substations for Ameren. He doesn't think a substation, as far as noise or any type of environmental impact, has ever been studied.

Mr. Dunn: Mr. Dunn said he did not think so.

Brad King: Mr. King is from E.ON Climate & Renewables Twin Forks Wind Farm, 353 N. Clark Street in Chicago. Essentially, kind of the long and short of it is that the substation itself will have to adhere to all Illinois Pollution Control Board standards for noise. So, it would not have an adverse impact from a noise standpoint on her residence.

Mrs. Hans: Mrs. Hans said she understands from their road commissioner that there will be a contract to fix the roads with the heavy equipment so it won't go back to the taxpayers.

Mr. King: Mr. King said the work on the substation actually does not require any heavy load equipment. We would be utilizing rated vehicles on rated roads, and it would be a minimal increase to traffic. The construction we are proposing here is a relatively small scope and short period of time. For a wind farm we would enter into a full road use agreement which would require potential upgrades where necessary and full restoration following construction. But, again this is just for the collector substation.

Mrs. Hans: Mrs. Hans asked what kind of compensation there will be for people who live there but do not own land. If a windmill is not on your land but you are looking at it and you are hearing it, is there any compensation?

Mr. Dunn: Mr. Dunn said we are talking about a collector substation, not the wind turbines themselves. Those will be addressed, maybe, at a later date.

Mrs. Hans: Mrs. Hans said if the substation is going up, would they take it down if the farm doesn't go?

Mr. Williams: Mr. Williams said all they are actually going to do is some grating work and put foundation in and some fence up. That is what this zoning hearing is for. He also wanted to pointed out that is says in the resolution, "said property and all operations upon said property shall remain subject to all other applicable local, County, State and Federal regulations." Mr. Williams said that is where we have hopefully built in some protection for the residents out there.

Allan Hans: Mr. Hans lives at the same address 5602 W. Duroc. He understands you have to comply with the Illinois Pollution Control Board standards. As he understands it there haven't been any changes to that standard since maybe 1979. So, he is wondering if

the rules, the codes, the protection for citizens have caught up with the technology. The people who have to live next to these windmills and the substation, we need to make sure that we all can be good neighbors and live together in this environment.

Mr. King: Mr. King said the sound emitted from the substation is extremely low. Typically it is audible when you are at the substation itself or perhaps parked along the side of the road, not at residences at a distance. The closest residence to the substation that is proposed is roughly 1300 feet. So, you would not be able to hear it at that distance.

Mr. Hans: Mr. Hans said he understands this is to do with the substation, but we have to understand that the substation is prior to the construction of these windmills. Again, he asked if the Illinois Pollution Control Board standards have kept up with the technology. Do they have noise restrictions that are consistent with the construction of windmills that have occurred in the last 3, 4, 5 years? He just wants to get that on the record.

Paul Heft: Mr. Heft said he is the Highway Commissioner in Austin Township. Most of you know who he is. This project will be a wonderful godsend for Austin Township and our road problems and bridge problems with the many closings and money we owe for bridges. As he stated at the zoning meeting, he has been to 5 different farms. He goes by himself and has studied them. He has been beside them. There is no noise from these transmission stations. He has been to one near Paxton that is the same company as Mr. King's. It is no different than the transmission stations downtown or wherever here in town that Illinois Power has got. There is no noise. That is his study as road commissioner for Austin Township. He hopes they will all support it because it is the project they need out there for the most bridges in Macon County and the most bridges in the State of Illinois by one township, which is Austin Township.

Mr. Ashby: Mr. Ashby asked if this Special Use Permit granted to these people eliminates us from other special permits for other wind farm do overs.

Mr. Dunn: Mr. Dunn said no.
