Tilton. He had attended Mt. Zion High School and went on to graduate from Lincoln Challenge Academy, Rantoul, Illinois. He attended Richland Community College and went on to serve as a medic with the U.S. Army 1st Battalion, 508th Parachute Infantry Regiment, 4th Brigade Combat Team, of the 82nd Airborne Division, Fort Bragg, North Carolina. His awards and decorations include, the Bronze Star Medal, Purple Heart, the Army Commendation Medal, the Army Achievement Medal, the Army Good Conduct Medal, the National Defense Service Medal, the Afghanistan Campaign Medal with Campaign Star, the Global War on Terrorism Service Medal, the Army Service Ribbon, the Overseas Service Ribbon, the NATO Medal and Combat Medic Badge. He was also a member of the Long Creek United Methodist Church.
