Mr. Oliver: Mr. Oliver asked why this was changed. What is the reason for this?

Mr. Dunn: Mr. Dunn said Judge Webber might want to speak to this or Mike Baggett. There has been some confusion because of the name. Most county places that do business with the courts, it is named the courthouse.

Judge Webber: Judge Webber said it has been a small rock in his shoe as long as it has been there. We have 102 counties in Illinois and most places it is the courthouse. He said in McLean County it is the Law & Justice Center, and in Chicago it is the Richard J. Daley Center. We have the facility. Judge Webber feels it lacks the dignity that should go with the courthouse. It always was the Macon County Courthouse. The court facility got attached to it, he thinks, as part of some of the refinancing. He asked Mike if that was correct.

Mr. Baggett: Mr. Baggett said that was correct. Back when they remodeled in the late 90's, our bond counsel, when they issued the 97' Bond Issue for some reason named it the Courts Facility. It got stuck in there as one of the various names of our buildings. It stuck really hard; so this is going to be able to fix that, particularly now that the bond is paid off.
