He had talked with Chairman Dunn about this. It involved the Homestead Exemption and senior exemptions. It could have cost us quite a bit of money, but it also dealt with a tax freeze. That did not go anywhere, so the earliest anything like that could come up would be at the end of January when they come back.

PRESENTATION OF THE ANNUAL APPROPRIATIONS BUDGET FOR DECEMBER 01, 2017 THROUGH NOVEMBER 30, 2018

COMMENT:

Mr. Greenfield: Mr. Greenfield said first of all he wanted to thank the Finance Committee for working on the budget this year because by all means it wasn't pleasant. He especially wanted to thank the officeholders for being cooperative and working with us as well as they did. Unfortunately, next year doesn't look to be much better; so all we can do is hope for the best. We were about \$580,000 of being at a balanced budget which was about \$1,600,000 that we had to cut on top of still not having the \$580,000. Some officeholders cut as much as they could cut. It is really tough out there. Next year, like he said, does not look any better. Hopefully we are not going to get into layoffs, but unfortunately as far as the cuts go, that will probably be our next step.
