The reason being that CDL drivers, and they're all CDL drivers out there at the Highway, that the county was starting to lose them to other jobs. There are so many places that don't have employees with CDL's that pay tremendously more money than what the County Highway Department does. Also, they did a comparison with other County Highway Departments the same size as Macon County's, and they were way behind the eight ball on that as well. To keep the employees, and honestly they are still cheaper than the other counties, considerably, but it was a start to try and get the employees back to where they are at least in a competitive market. He thinks it is around 6% to 6.5%. But, some of them were higher than others because the starting pay was... Minimum wage was going to be ahead of what the CDL drivers were making. They felt it was time they brought the highway into... He said most of the guys out there are running heavy equipment. They are called in to plow snow. The wages they are currently being paid were far under what the market bares.

Mrs. Dawson: Mrs. Dawson said there was no argument on her part. She just wanted to know what their yearly percentage was.
