**MACON COUNTY BOARD RESOLUTION
INCREASEING COMPENSATION OF
ELECTION JUDGES**

RESOLUTION NO. G-

WHEREAS, the current compensation for an Election Judge in Macon County is set at a base amount of \$125.00 and an additional \$25.00 for those who have completed a training course within the two years preceding Election Day for a total of \$125.00 without training and \$150.00 with training; and

WHEREAS, Public Act 103-0008 effective June 7, 2023 which in part amends the Election Code at 10 ILCS 5/13-10 increasing the State Board of Elections Election Judge compensation reimbursement by an additional \$20 (currently \$45); and

WHEREAS, said Public Act states that this increase may not be used by the County to reduce its portion of an Election Judge's compensation; and

WHEREAS, there is a need to have a sufficient number of trained Election Judges to administer elections.

NOW, THEREFORE, BE IT RESOLVED by the Macon County Board that beginning with the March 19, 2024 General Primary the base compensation for Election Judges shall be \$165.00; and

BE IT FURTHER RESOLVED that Election Judges who have completed the training course within the two years preceding the day of election shall receive an additional \$25.00; and

BE IT FURTHER RESOLVED that the compensation for an Election Judge in Macon County is established at a base amount of \$165.00 and an additional \$25.00 for those who have completed a training course within the two years preceding Election Day for a total of \$165.00 without training and \$190.00 with training
