Auditor's Office -

Ms. Reed reported that the first insurance committee meeting of the year will be held on March 1st. The purpose will be to talk about the upcoming (July 1st) health insurance renewal. The meeting will be at 9 a.m. on the 8th floor. She invited anyone interested to attend. She explained that they are not really sure what the new rates will be, but they've been informed that it should be very low. She said they will still look at other possibilities as far as self-insurance, but John Malachowski has indicated that the fully insured plan that we currently have should only be about a 1% to 2% increase. No guarantees, but that is how it is looking. Mr. Meachum turned (away from mic) to Ms. Reed and asked a question about the amount she had budgeted. Ms. Reed explained that it would be from July to November and they had planned for an increase. Mr. Meachum asked if she had planned for enough. She said she hoped so.

County Board -

Chairman Dunn reported that there will be a blood drive in March and information should be coming out in the next day or so.

Mr. Dunn explained that there will be a public hearing prior to the transportation committee meeting on the quick take process where they are trying to get some right of way at the NE corner of Brush College and 48. He said they were hoping to be able to negotiate a price before it actually has to go and be approved by the legislature. Mr. Meachum added that board members do not have to be present for that. Mr. Bruce Bird would be running it.

Macon County Board Resolution Approving Budget Amendment for Workforce Investment Solutions FY17 Budget – NEG Regional Planning Grant

The alignment involves the development and / or process of business engagement on a regional level. The plan includes Decatur, Springfield, and Carlinville.
