Macon County Board Resolution Approving Increase in Appropriations in the FY2020 County Clerk Elections Budget

Mr. Tanner explained that this is for a grant from the Center for Tech and Civic Life in the amount of \$66,352 to help administer the election in light of the COVID-19. This is a corresponding increase in revenue and expenses. Anything that is not spent, according to the grant, will be returned.

Mr. Oliver asked if this is the first time for this. Mr. Tanner confirmed saying that we have never received a grant from this particular organization before. Workforce Investments -

Macon County Board Resolution Approving Workforce Investment Solutions FY20 Budget -Layoff Aversion Project

Ms. Wilkerson explained that this is in the amount of \$101,348.41. This was the grant they got from DCEO to assist with local employers so that they could keep their help and not have to lay people off. This money saved 137 positions which was a good outcome. Mr. Jackson asked if they had to quantify their need. Ms. Wilkerson said they had to fill out a lot of paperwork to explain to DCEO that if they didn't get some assistance, they would have to lay staff off. With that, Workforce was the facilitator of the paperwork, getting the grant, securing the grant and with that they were able to keep their employees. It was a COVID thing.

Motion was made by Mr. Jackson, seconded by Ms. Joy, to approve forwarding the resolution on to the Finance Committee with recommendation for approval. Roll call vote showed the motion carried 5-0.
